1/ LOCAL QUALIFYING: TBCA MEMBER CENTERS MAY CONDUCT "HOUSE QUALIFYING "BETWEEN OCTOBER 1, 2007 THRU MARCH 10, 2008.

2/ LOCAL QUALIFYING: WILL CONSIST OF A 3-GAME SET. TOTAL PIN-FALL PLUS HANDICAP WILL DECIDE WINNERS. MULTIPLE PARTICIPATION WILL BE ALLOWED ON THE LOCAL LEVEL.

THE SAME TWO INDIVIDUALS AS A TEAM CAN ADVANCE TO THE STATE FINALS ONLY ONCE.

3/ ENTRY FEE: THE LOCAL QUALIFYING ENTRY FEE IS \$15.00 PER TEAM PLUS LINEAGE. \$30 MUST BE FORWARDED TO TBCA FOR EACH TEAM ADVANCING TO STATE. ADD AN ADDITIONAL \$15 FOR EACH EXTRA TEAM ADVANCING TO STATE WITH MAJOR FRACTION THEREOF.

4/ ADVANCEMENT RATIO: ADVANCEMENT TO STATE FINALS FROM LOCAL QUALIFYING WILL BE 50 % OF TOTAL ENTRIES IN EACH DIVISION. ROUNDING UP IN EACH DIVISION IS ALLOWED. EXAMPLE: 3 ENTRIES = 2 ADVANCE TO STATE.

5/ IF THERE IS A TIE FOR LAST PLACE IN THE QUALIFIER, THEN A ONE-GAME ROLL-OFF IS NECESSARY TO DETERMINE STATE FINALIST TEAM.

6/ ANY STATE ENTRY MUST ADVANCE THRU QUALIFYING.

7/ ENTRIES INTO STATE FINALS MUST BE POST-MARKED BY MARCH 14, 2008. ALL ENTRIES ARE TO BE MAILED TO: TBCA, 5700 GROVER AVE, AUSTIN, TEXAS 78756.

8/ THE STATE FINALS WILL BE CONDUCTED AT DART BOWL, AUSTIN ON APRIL 26-27, 2008. A 6-GAME BLOCK WILL BE BOWLED BY EACH TEAM IN STATE FINALS COMPETITION.

A LINEAGE FEE OF \$ 38.00 IS REQUIRED AT CHECK-IN TO DART BOWL. THIS ENTRY FEE IS FOR BOTH ADULT AND YOUTH BOWLERS WHO BOWL 6 GAMES EACH.

9/ ONE TEAM FROM THE PARENT/TEEN AND PARENT/YOUTH DIVISIONS WILL ADVANCE TO THE NATIONAL FINALS.

10/ ADDITIONAL GRAND PRIX SCHOLARSHIPS WILL BE GIVEN AS FOLLOWS: 1ST PLACE \$ 250, 2ND PLACE \$150, 3RD PLACE \$100 IN EACH OF THE FOUR DIVISIONS.

STATE FINALS: FIVE MINUTES OF PRACTICE IS GIVEN BEFORE TOURNAMENT COMPETITION. THERE IS ROTATION OF ONE PAIR OF LANES AFTER THE FIRST 3 GAME BLOCK, AND A TEN-MINUTE BREAK IS GIVEN. IT IS RECOMMENDED FROM THE CENTER TO HAVE 3-4 TEAMS PER PAIR.

THE DIVISIONS CAN BOWL TOGETHER AND THE CENTER CAN PRE-ASSIGN LANES THE NIGHT BEFORE THE EVENT. THERE IS NO PRACTICE BEFORE THE SECOND SET.

THE TEAM IN EACH OF THE FOUR (4) DIVISIONS OF THE FINALS COMPETITION WITH MOST PINS PLUS HANDICAP FOR THE SIX (6) TEAM GAMES WILL BE DECLARED THE STATE FINALS WINNER IN EACH DIVISION.

11/ GRAND PRIX SCHOLARSHIP POINTS (DOLLARS) WILL BE AWARDED FROM STATE FUNDS OF THE GRAND PRIX TO GRAND PRIX REGISTERED YOUTH BOWLERS THAT PARTICIPATE IN THIS TOURNAMENT AT THE RATE OF 1 POINT FOR LOCAL ENTRY AND 4 ADDITIONAL POINTS IF ADVANCING TO STATE FINALS.

12/ PARTICIPANTS MAY WEAR SKIRTS, LONG PANTS OR WALKING SHORTS. WE DEFINE WALKING SHORTS AS CLOSE TO KNEE-LENGTH. IF THE BOWLERS PLACE THEIR HANDS STRAIGHT DOWN AT THEIR SIDES AND ARE ABLE TO TOUCH SKIN THEN THE SHORTS OR SKIRTS ARE NOT LONG ENOUGH AND THE BOWLER WILL BE REQUIRED TO CHANGE CLOTHING BEFORE COMPETING IN THE TOURNAMENT. IN ADDITION, ALL ATTIRE MUST BE HEMMED, NOT ROLLED. ALL SHIRTS AND BLOUSES WORN WILL HAVE SLEEVES AND BE LONG ENOUGH TO BE TUCKED IN. HOWEVER, WE DO NOT REQUIRE THE BOWLERS TO TUCK IN THEIR SHIRTS. THE FOLLOWING ATTIRE IS NOT ALLOWED: ATHLETIC SHORTS, BICYCLE PANTS, SOCCER SHORTS, TANK TOPS, HALTER TOPS, ABBREVIATED TOPS, SLEEVELESS SHIRTS OR BLOUSES, UNDERSHIRTS, HATS, CAPS, BANDANAS OR REVEALING ATTIRE. FINAL DECISION CONCERNING THE DRESS CODE RESTS WITH THE TOURNAMENT DIRECTOR.

13) IMPORTANT - READ CAREFULLY: IT SHALL BE EACH BOWLER'S RESPONSIBILITY TO DETERMINE THAT THE SUBMITTED AVERAGE IS CORRECT. IF THE SUBMITTED AVERAGE IS LOWER AND RESULTS IN MORE HANDICAP, THE BOWLER'S SCORE WILL BE DISQUALIFIED. AVERAGE CORRECTIONS CAN BE MADE UP TO THE END OF THE BOWLER'S FIRST GAME OF A SERIES.

14/ QUALIFYING AVERAGES: PARTICIPANTS SHALL USE THE HIGHEST AVERAGE FROM THE 05-06, 06-07, OR CURRENT SEASON AS OF DATE OF ENTRY. ALL AVERAGES MUST HAVE MINIMUM 21 GAMES (14 GMS FOR BANTAMS). SUMMER AVERAGES MAY BE USED IF THE BOWLER HAS NO BOOK AVERAGE FOR THAT YEAR. SUMMER 2006 SHALL BE CONSIDERED AS A 2005-06 AVERAGE; AND SUMMER 2007 SHALL BE CONSIDERED AS A 2006-07 AVERAGE. STATE AVERAGES: - PARTICIPANTS SHALL USE THE HIGHEST OF THE FOUR AVERAGES LISTED (MARCH 1, 2008) INCLUDED. ALL AVERAGES MUST HAVE A 21 GAME MINIMUM OR 14 GAMES FOR BANTAMS.
